



Where to send Australian visa medicals

To determine the correct destination of medical results:

1. Check if the name of a DIAC processing office outside of Australia (Embassy/Consulate-General/High Commission) is on the Forms 26/160 or in a letter requesting the examinations – if so, send the results to this address.
2. If no DIAC office address is on the Forms 26/160 or in a letter, check if the table below lists the class or name of visa the applicant is applying for - if so, send the medical results to the Health Operations Centre (HOC). In addition, Panel clinics in China and India need to note that HOC processes:
 - all subclass 570-580 student visas from People’s Republic of China;
 - all subclass 570-580 student visas lodged electronically (eVisas) from India.
3. If the visa class is not listed in the table below send the medical results to the local DIAC processing office outside of Australia (Embassy/Consulate-General/High Commission). If you are unsure which local DIAC office processes the medical results please contact HOC.
4. If an applicant does not know the visa class they are applying for send the medical results to HOC.

The following exceptions apply to visa class medical results from China, Hong Kong and Taiwan ONLY:

- 1 **132** In China and Hong Kong, send to the Australian Consulate-General in Hong Kong.
- 2 **160 - 165** In China and Hong Kong, send to the Australian Consulate-General in Hong Kong; in Taiwan send to the Australian Commerce and Industry Office (ACIO).
