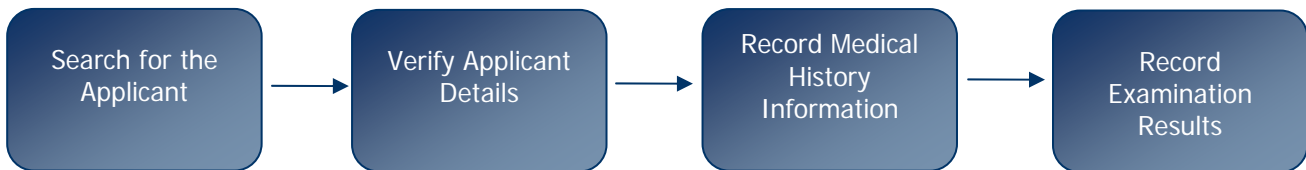





## eHealth for Paper Visa Applicants



### Search for the applicant

Clients who have lodged a paper visa application but are eligible for eHealth will present with a 'Health Examinations List'. An example letter is shown below.

## Record medical history

For paper visa applicants, you are required to complete the medical history questions on behalf of the client.

Select the **Record Medical History** link against the requirements to be completed by your clinic (x-ray examination, medical examination, or both).
