4. Employees of Tempo Facility Services Pty Ltd, A.C.N. 001 806 097, A.B.N. 12 001 806 097, who perform duties under the Act and who have met character and training requirements as set out in the Detention Services Contract;
5. Employees of Delaware North Australia Pty Ltd, A.B.N. 92 003 435 345 (trading as) AFS Catering Pty Ltd A.C.N. 004 292 951, A.B.N 45 004 292 951

who perform duties under the Act and who have met character and training requirements as set out in the Detention Services Contract; and

6. Employees of Davidson Trahaire (trading as) Professional Support Services Pty Ltd, A.C.N. 008 522 610, A.B.N. 21 008 522 610, who perform duties under the Act and who have met character and training requirements as set out in the Detention Services Contract.
