**AUTHORISATION OF EMPLOYEES OF THE DEPARTMENT OF FOREIGN
AFFAIRS AND TRADE TO BE OFFICERS FOR THE PURPOSES OF THE
*MIGRATION ACT 1958***

I, *AMANDA VANSTONE*, Minister for Immigration and Multicultural and Indigenous Affairs, acting under paragraph (f) of the definition of "officer" in subsection 5(1) of the *Migration Act 1958* ("the Act"):
