Please address clause 132.211*, 132.212, 132.213, 132.214, 132.216, 132.217 of the <i>Migration Regulations 1994</i>.</p> <p>*Provide details if any of your businesses have operated at a loss or is/has been subject to insolvency, receivership or liquidation.</p>	
<p>b) Evidence of business ownership:</p> <p>i) business registration certificate or licence</p>	
<p>ii) evidence of share of ownership. This may include:</p> <ul style="list-style-type: none"> <li>• evidence of purchase</li> <li>• share registers/ company registers/ share transfer documents</li> <li>• historical company extracts</li> <li>• annual returns of directors and shareholders</li> <li>• partnership/trust/franchise agreements.</li> </ul>	
<p>c) Evidence that you have participated in the day to day management of the business for two (2) of the four (4) fiscal years prior to application, which may include:</p> <ul style="list-style-type: none"> <li>• business contracts</li> <li>• minutes of meetings</li> <li>• documents initiated or authorised.</li> </ul> <p>Evidence needs to demonstrate involvement in decisions about the management of the whole or substantial part of the business and responsibility for such areas as strategic management, recruitment, price structure, business profitability, expenditure.</p>	

<p>d) Extracts from financial statements for your business, prepared by an independent accountant to International Accounting Standards, including balance sheet, profit and loss statement and notes to the accounts. Financial statements must be provided for two (2) of the four (4) fiscal years prior to application.</p>	
<p>e) Other business documents:</p> <p>i) One page organisational chart showing your position in the business, staff attribution, management lines and functional responsibilities.</p>	
<p>ii) Photos of business premises and business activities (maximum 6 photos).</p>	
<p><b>NET ASSETS OF YOU AND/OR SPOUSE AVAILABLE FOR TRANSFER WITHIN TWO (2) YEARS OF GRANT</b></p>	
<p>A one page summary statement outlining ALL assets and liabilities <u>on a single day</u> in the three (3) months preceding your application.</p>	
<p>Evidence of ownership and value of assets (minimum \$1,500,000 of assets, excluding liabilities, must be demonstrated).</p> <p><b>You must include evidence of liabilities (if any) against each asset (for example mortgages, loans including unsecured and third party loans, and credit cards).</b></p> <p>If you wish to include assets held by a trust, you must include a copy of the trust deeds.</p>	
<p>i) For cash assets:</p> <ul style="list-style-type: none"> <li>• bank statements, on a single day in the three (3) months preceding your application. All bank statements must have the same date of issue.</li> </ul>	
<p>ii) For real estate assets:</p> <ul style="list-style-type: none"> <li>• evidence of ownership (title deeds)</li> <li>• evidence of value (valuation certificate by an accredited property valuer). <b>Note:</b> Valuations by real estate agents who are not accredited property valuers are generally not acceptable.</li> </ul>	
<p>iii) For business net assets:</p> <ul style="list-style-type: none"> <li>• evidence of ownership and value as outlined at 2(b) and 2(c). (Cross reference folios to 2(b) and 2(c) where applicable).</li> </ul>	
<p>iv) For personal or business loans:</p> <ul style="list-style-type: none"> <li>• loan agreements, loan statements indicating amount borrowed and repayment schedule, listed in business balance sheet (if loan to/from a business).</li> </ul>	
<p>v) For stocks and bonds:</p> <ul style="list-style-type: none"> <li>• share or bond registers, share/fixed interest securities/debentures certificates, transfer certificates.</li> </ul>	

PERSONAL DOCUMENTS	
Certified copies of passport or travel documents of all persons included in the application.	
<a href="#">Form 47A</a> <i>Details of child or other dependent family members aged 18 years or over</i> This must be completed for all dependants aged 18 or over.	
Evidence of dependency for all dependants aged 18 or over.	
Certified copies of birth certificates or the family book, showing names of both parents, for all persons included in the application.	
If you or anyone included in the application is, or has been married, certified copies of the marriage certificate(s). If you are living in a defacto relationship, independent evidence that you have been in the relationship for at least 12 months (for example joint bank account statements, billing accounts in joint names).	
If you or anyone included in the application has been divorced or widowed, a certified copy of the divorce decree absolute or the death certificate of the deceased spouse (as appropriate).	
If anyone in the application has changed his or her name (for example by marriage or deed poll), a certified copy of evidence of the name change.	
If any dependant child included in the application is adopted, certified copies of the adoption papers.	
Certified copies of documents to verify custody and access arrangements for children under 18 years of age. This is not required if both parents are included in the application.	
For each dependant aged 18 years or over, evidence of English language proficiency. If applicant has functional English or higher - provide results of an IELTS test taken not more than 12 months before application or alternative evidence as outlined in booklet 7. If applicant has less than functional English – provide declaration. <b>See:</b> <a href="#">Booklet 7 Business Skills Entry</a>	
Four recent passport sized photographs (45mmx35mm) of your and any other person included in the application. <ul style="list-style-type: none"><li>• These should be of the head and shoulders only against a plain background.</li><li>• Print the name of the person on the back of each photograph.</li></ul>	
If you have served in the armed forces of any country, certified copies of military service record or discharge papers. <b>See:</b> <a href="#">Character and Penal Clearance Requirements</a>	
All applicants must meet character requirements.
